- 2. Aliza Blair reviewed minutes 05/10, 2022. Val moderating.


  Motion to accept minutes as presented Sue Connell, 2<sup>nd</sup> Tonya Dedrick. Motion carried.
- 3. Establishing date AGM 2024, May 14, second Tuesday of the month. Motion to accept Aliza Blair, 2<sup>nd</sup> Fiona Frustaci. Motion carried.
- 4. Called upon Cathy Jaques, Treasurer, to present 2022 financial statements. Statements to be attached to minutes.
  Moderator motion to approve. 1<sup>st</sup> Colleen, 2<sup>nd</sup>- Sylvia Bray. Motion carried.
- Cathy speaks on Accountant Cathie Hunt 2023, board recommendation to retain her for taxes 2023, but potential to change for 2024.
   Motion to accept for 2023 - Sue Connell, 2<sup>nd</sup> – Pat McCrindle. Motion carried.
- 6. Cathy spoke on bursary disbursements for 2023. Recipient qualifications, picked by schools, and presented by board members at graduation ceremonies. Called for new members, mentioned committees returning. Clarified resignation, executive membership, directors, students.
- 8. Colleen Nominated existing board members to rejoin the board for 2023/2024. Sabrina Harding, Amanda Mazotta, Jane Frustaci volunteered to join the new board as directors. Motion to accept new members by Tanya, 2<sup>nd</sup> Colleen. Motion carried. Cathy Jaques noted that Casey James wishes to resign when a suitable replacement can be located.











- 9. Tonya Dedrick acknowledged the effort and positivity of the board, expressed interest in the committees.
- 10. Cue cards pulled for the Membership draw. Past president Hannah McEdwards preselected a number, presented via played pre-recorded video. Number 11 selected. Prize winner was Jane Frustaci. Award certificate presented by Debra Harrison.
